AGREEMENT

16th WORLD YOUTH BRIDGE TEAMS CHAMPIONSHIP

THIS AGREEMENT dated 31/2014

Between THE WORLD BRIDGE FEDERATION ("the WBF"), represented by its President, Gianarrigo Rona AND the CITY OF SALSOMAGGIORE TERME ("the Host City"), represented by its Mayor, Filippo Fritelli AND the CONVENTION BUREAU SRL, represented by its Administrator, Alessandra Bonati AND the FEDERAZIONE ITALIANA GIOCO BRIDGE – FIGB – ("the Host NBO"), represented by its President, Gianni Medugno,

WITNESSETH

- 1. Subject to the terms and conditions of this Agreement, set forth both herein and within the Specification attached hereto, the WBF awards to the Host City and the Host NBO and the Host City and the Host NBO hereby agree to host the 2016 World Youth Bridge Teams Championship (Juniors, Youngsters, Girls & Kids together called "the Championship"). The Host City and the Host NBO shall give their support, name and goodwill to the success of the event, fulfilling its obligation under this Agreement.
- 2. The Championship will be held at the Palazzo dei Congressi, Salsomaggiore Terme, Italy, from Wednesday 3rd to Saturday 13th August 2016. The Palazzo dei Congressi will host the Playing Area and all the connected services.
- 3 The main division of responsibility between the WBF and the Host NBO has been agreed with a separate contract whose this agreement constitutes integral part, assuming the Host NBO the responsibility of its execution.
- 4. The Host City shall bear the cost of and be responsible for:

- a) providing the entire area of the Palazzo Dei Congressi to set the Playing Area, the Hospitality desk, the Information Desk, the Main Office, the Scoring Room, the Daily Bulletin Room, the Duplication Room, the President & WBF Office, the Meeting Room, the Vu-graph theatre, Open Rama Room, the Main Lobby, the First Aid and Antidoping Testing Room, and the rooms for the other services requested by the organisation of the event. The playing area and other areas that require special equipment to be set up are made available to the WBF staff from no later than two days before the Opening Ceremony and up to one day after the Closing Ceremony. During the time from the Opening to the Closing Ceremony the complete Championship Arena and its facilities are available for the Championship
- b) providing appropriate entertainments, including at least:
 - an Opening Ceremony and Cocktail for approximately 400 people at 19.30 on Wednesday 27th July 2016
 - a Closing Ceremony with Cocktail-Buffet for approximately 400 people at 19:00 on Saturday 7th August 2012, providing podium, flag-raiser, and such other requirements necessary for the Prizegiving ceremonies
- c) providing a suite for the WBF President and his spouse, 10 single and 12 double rooms (34 people) with full board accommodation free of charge for the WBF Officers and Staff Operators, as per following:.

4 Star Superior Hotel:

1 suite for the WBF President and his spouse

4 single and 5 double rooms for WBF Officers

The Suite, 2 single and 1 double room have to be available from 3 days before the Opening Ceremony up to up to the day of the Closing Ceremony; the other rooms have to be available from 1 day before the Opening Ceremony up to the day of the Closing.

3 Star Superior Hotel:

6 single rooms and 7 double rooms for WBF Staff Operators

At least 4 double rooms have to be available from 3 days before the Opening Ceremony up to up to the day of the Closing Ceremony; the other rooms have to be available from 1 day before the Opening Ceremony up to the day of the Closing.

d) provision for making block bookings of rooms (Full Board Accommodation) for any other WBF Officers & Staff Operators as may be needed (to be paid for by WBF) and players and any companions (to be paid by them) at a special agreed daily rate per person as follows:

 Single Room: 90 Euros
 Double Room 70 Euros
- 3 Star Hotels
 Single Room 70 Euros
 Double Room 55 Euros
 Triple Room 45 Euros
- 5. The schedule of the Championship shall be as decreed by the WBF. The WBF maintains full executive control over all technical aspects of the Championship including being responsible for all decisions concerning the staffing, management and running of the Championship.
- 6. The identity of the Championship Arena and Hotels shall not be changed by the Host City for any reason whatsoever without the prior written consent of the WBF.
- 7. The Championship will be conducted under the sanction and control of the WBF and in accordance with Rules and Regulations prescribed by the WBF under the Laws of Duplicate Bridge 1999.
- 8. The meal times at the recommended hotels shall be in accordance with the requirements of the schedule of play.
- 9. For the avoidance of doubt it is hereby agreed as follows:
- (a) the WBF has total control on the sponsorship and the property of the logo and image of the Championship and nobody is authorised to modify or to print, publicise and/or develop it without the WBF's express written authorisation;
- (b) the WBF has total property ownership of the image, pictures, movie, data (etc.) of the Championship and nobody is authorised to print, publicise and/or develop it without the WBF express written authorisation;
- (c) the WBF has total control of the format and contents of the Daily Bulletin and all press-releases, information and communications concerning the Championship;

- (d) the entry fees are the property of the WBF and the WBF has control over the fixing of and collection of the entry fees for the Championship which shall be paid directly to the WBF by the NBOs.
- 10. The rights, duties and obligations of the Host City, the Host NBO and the WBF under the Agreement are subject to the following provisions:
- (a) no party shall assign this Agreement without the other Parties' written consent nor shall the Agreement be deemed assignable by operation of law without such consent;
- (b) any controversy or claim arising out of or under this Agreement or any breach thereof shall be arbitrated in accordance with the Rules then applicable of the Court of Arbitration of Sport. Any such arbitration shall be held in Lausanne, Switzerland, unless the parties otherwise agree;
- (c) this Agreement shall be construed under the laws of Switzerland;
- (d) this Agreement is intended for the sole benefit of the Parties hereto and no third party shall have any rights whatsoever against any of the Parties hereto by virtue of the provision hereof;
- (e) no modification of any the terms hereof shall be valid unless in writing and executed by the Parties with the same formality as this agreement.
